AceDoor Systems 2013 Limited has provided this declaration to satisfy the provisions of Schedule 1(d) of the Building (Building Product Information Requirements) Regulations 2022.

Product/system

Name

B-Series Roller Door

Description

B-Series Roller Doors are a residential / light commercial roller door product. The doors are constructed from pressed colour steel sheets seamed together with nylofelt stapled up each side to act as a wear surface in the guides. A full range of sizes are available within 1900mmH to 4200mmH, and 1000mmW to 4000mmW. B-Series Roller Doors are available with electric door openers from the Merlin range of products. The doors can alternatively be manually operated and secured with center lock, slide lock, or a custom solution by the end user (e.g hasp & staple)

B-Series Roller Doors are not fire rated.







Scope of use

B-Series roller doors are suitable for use in residential buildings as a garage door, or light commercial buildings as a workshop or shopfront door. They can also be used as doors for sheds and other similar buildings.

B-Series roller doors are not available with windows built in and so cannot be used to provide natural light in areas where natural light is required.

B-Series roller doors are not suitable to provide ventilation to the building interior.

B-Series roller doors cannot be insulated.

Conditions of use

B-Series roller doors must:

- Be installed to a covered or internal area and have the main door drum be protected from the elements.
- Be installed by a competent and experienced roller door installer.

B-Series roller doors cannot be used where there are fire rating requirements.

Openings must be designed with the minimum requirements given in the A & B-Series Roller Door Fixing Details document.

Not suitable for use in Exposure Zone D.

Structure

B-Series roller doors use robust construction and durable materials to minimise risk of collapse during construction, alteration, and throughout their lives. Likewise, the materials and construction used minimise deformations and vibrations that could cause discomfort or inconvenience to the building's occupants. Account has been taken for relevant physical conditions, including self-weight, imposed gravity loads and impact to ensure the doors can withstand these forces without being compromised.

Durability

B-Series roller doors have a durability of at least 15 years under normal use conditions, and when correctly maintained.

External Moisture

B-Series roller doors are fitted with a bottom weather seal to limit ingress of moisture. The door continuous colour steel curtain does not allow water to leak through joins.

Hazardous Building Materials

B-Series roller doors are safe when handled.
