AceDoor Systems 2013 Limited has provided this declaration to satisfy the provisions of Schedule 1(d) of the Building (Building Product Information Requirements) Regulations 2022.

Description

DuraShutter Doors are a commercial / industrial roller door that has been designed and tested to meet the wind load requirements of AS/NZS 4505. The doors are constructed from individual interlocking roll formed steel slats, steel guide channels and a heavy duty steel barrel with internal torsion spring counter balance system. The doors can be supplied with either a galvanised finish or powder coated screen.

A full range of sizes are available with heights up to 7000mmH, and widths up to 8000mmW. For more information go to <https://www.acedoors.co.nz/durashutter/>.

DuraShutter Doors can be operated by either a manual hand chain (limited size range) or by single or three phase electric openers.

DuraShutter Doors are not fire rated.



Scope of use

DuraShutter Doors are suitable for use in commercial buildings as a workshop or vehicle access door, or industrial buildings for vehicle or plant access. They can also be used as doors for sheds and other similar buildings.

DuraShutter Doors are not available with windows built in and so cannot be used to provide natural light in areas where natural light is required.

DuraShutter Doors cannot be insulated.

DuraShutter Doors are rated to meet the wind load requirements of AS/NZS 4505:2012 and so can be used in wind zones up to 2.0kPa.

Conditions of use

DuraShutter Doors must:

- Be installed to a covered or internal area and have the main door drum/barrel be protected from the elements.
- Be installed by a competent and experienced roller shutter door installer.

DuraShutter Doors cannot be used where there are fire rating requirements.

Openings must be designed with the minimum requirements given in the DuraShutter Door Drawings documents.

Not suitable for use in Exposure Zone D.

Contributions to compliance

Structure

DuraShutter Doors use robust construction and durable materials to minimise risk of collapse during construction, alteration, and throughout their lives. Likewise, the materials and construction used minimise deformations and vibrations that could cause discomfort or inconvenience to the building's occupants. Account has been taken for relevant physical conditions, including self-weight, imposed gravity loads and impact to ensure the doors can withstand these forces without being compromised. DuraShutter Doors have also been designed and tested to meet the wind load requirements of AS/NZS 4505:2012 and can be used in wind zones up to 2.0kPa.

Durability

DuraShutter Doors have a durability of at least 15 years under normal use conditions, and when correctly maintained.

External Moisture

DuraShutter Doors are fitted with a bottom weather seal to limit ingress of moisture. The door individual steel slats making up the curtain are profiled to not collect water or allow it to leak through joins.

Hazardous Building Materials

DuraShutter Doors are safe when handled.
